GENERAL CONDITIONS OF BOOKING

FORMULATION OF CONTRACT:

All bookings are made by the Parent or Legal Guardian of the Participant with VECSI Ltd. The submission of this Booking Form duly completed and signed by the Parent or Legal Guardian together with the deposit of €500 or the total price constitute an offer which shall not be binding on VECSI until such time as it has confirmed its acceptance in writing.

The following conditions shall govern any Contract with VECSI Ltd. The person signing the booking form and student identification form as Parent or Legal Guardian hereby unconditionally guarantees VECSI that he or she is the Parent or Legal Guardian of the Participant, and that he or she has legal custody of the Participant and gives his or her authority for the participant to take part in the VECSI programme.

THE PARENT OR LEGAL GUARDIAN HEREBY AGREES THAT:

(A) The family with whom the Participant is staying, herein after referred to as the "Host Family" has authority and control over the Participant;

(B) In the case of emergency VECSI Ltd. or its representative or French partners have full authority to take such actions as it may think fit at the expense of the Parent or Legal Guardian as the case may be.

(C) No alterations may be made to these Conditions of booking except by VECSI Ltd. in writing and no other Terms and Conditions may be incorporated into these Conditions of Booking.

(D) VECSI Ltd. reserves the right at any time to change in its absolute discretion the location of the Exchange/Homestay/ Language Programme or travel arrangements of any booking made, if circumstances change from the time of booking to the time of departure.

The Parent or Legal Guardian hereby agrees with VECSI Ltd. that it will immediately reimburse any family with whom the Participant may have stayed during the Home Stay Programme, any debts incurred by the Participant to any person whomsoever and any damage caused by the Participant to whomsoever.

This agreement as well as the conditions of booking shall be subject to and construed in accordance with Irish Law. In the event of any discrepancy in the meaning between any version of these conditions in any language other than English, the English version is to prevail.

The Legal Guardian or Parent hereby submits to the Jurisdiction of the Irish Courts.

TERMS OF PAYMENT

A deposit of €500 shall be paid on submission of this Booking Form which will be non-refundable.

VECSI Ltd. has the right to cancel the booking at any time prior to departure by notice in writing to the Parent or Legal Guardian of the Participant. In such event **VECSI Ltd.** will refund all money paid to it by the parent or Legal Guardian, but **VECSI Ltd.** accepts no other liability whatsoever in the event of such cancellation.

All anticipated costs, charges and fuel prices rises have been incorporated in the prices shown in the brochure, however **VECSI Ltd.** reserves the right to pass on fuel surcharges, and other cost increases imposed by a government or governments agency or any other third party included without prejudice to the generality of the foregoing increases in airport taxes, security charges, and impositions of any other new tax such as value added tax in either Ireland or France. Any such increase will be shown in the final invoice.

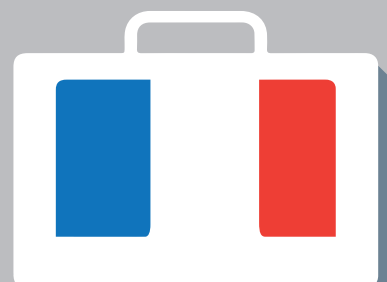
